

Parties to MOU:

- 3. Combined industrial and field visits for students of Party A and Party B.
- 4. Exchange of English and Dramatics faculty to impart knowledge in English Language and Linguistics and Theatre and Dramatics.

RELATIONSHIP OF THE PARTIES

For the purposes of this MoU, both the Partles are Independent contractors. Neither this MoU, nor any activities described herein, shall be construed as creating a partnership, joint venture, franchise, agency or other such relationship. Neither party is authorized, in any manner, to make any commitment on behalf of or to bind the other Party.

TERMINATION

Either Party may terminate this MoU by giving ninety (90) days advance written notice to the other Party. On termination, each Party shall return to the other party all such confidential and proprietary information, documents and reference material and copies there of the other Party in its possession.

This MoU can be extended or terminated by mutual consent of the Parties in writing.

ENTIRE AGREEMENT

This MoU, along with the schedules and exhibits, if any, attached hereto, sets forth the entire agreement between the Parties. No modifications or amendments to this MoU shall be binding upon the Parties unless made in writing and duly executed by authorized officials of both Parties.
