- ❖ Paid Rs. 1,31,000/- to the University
- University has started online affiliation it may take two months from now
- Good response for B.C.A
- Shortage of Class rooms.

11. Requirements for NAAC -

- Printer, Projector, Laptop and Computers (18 working computers)
- Library P U C building
- ❖ NSS Room PUC building

12. Salary and Staff requirement

- ❖ As per the direction of CBE, 50% of the salary is paid till now.
- Funds are available till August 2020.
- Lecturers are coming on alternative days for NAAC work.
- Mr. Melchidias, Mrs. Pramila and Mrs. Thanuja are instructed to go on holidays.

13. Admissions

- Till now 22 admission for B Com and 1 for BBA.
- ❖ If BBA gets only 25 students, we may have to admit 200 (100 in each section) for B Com. which might be difficult to handle in the present situation.
- ❖ Even though last year's admissions are 184 to continue with the present scale we have to admit 217 students (present outgoing) this year

14. Fee collections and Re-admissions

- ❖ Nearly 11,50,000/- last year fees are pending. We are requesting them to pay, but poor response.
- * Re-admissions and fees of 2020-21 we have not yet started to collect.

The meeting of the Local Management Committee of Padua College of Commerce and Management was held on Friday 03rd July 2020, in the Principal's Chamber at 4.00 p.m.

Most. Rev. Dr. Peter Paul Saldanha the President of CBE presided over the meeting. Rev.Fr. Vincent Monteiro the Correspondent of Padua Educational Institutions welcomed the members for the meeting. Mr.Roshan Santhumayor, Vice-Principal briefed about the activities held in the year 2019-20

Agenda Discussion:

The following Agenda was discussed and suggestions from the members were accepted:

- 1. Mr.Roshan Santhumayor put forward the development during lockdown period from March, 23rd to till date.
- 2. Members were informed about the NAAC and the work done with the help of St.Agnes College under Parmarsh Scheme, Date of final presentation of SSR and the date of filling IIQA were fixed for future date in the month of September. The requirements for NAAC were discussed as follows:
- -Two Rooms for Language and Audio-Visual classes
- -Spacious Library
- -NSS Room
- -Computer Lab
- -Additional requirements- Printers, Projectors, Laptop and Computers
- 3. It was suggested that all infrastructure like painting of the college building, purchasing of Printers, Projectors, Laptop and Computers have to be completed within the funds available in the college.
- 4. Infrastructure, digitalization of class rooms and extension of building was discussed in the meeting.
- 5. The members were informed about starting of BCA programme and the affiliation of the
- 6. Due to the lack of strength of BBA programme, the committee suggested that three BCom Classes can be accommodated instead of BBA programme
- 7. The members suggested to collect the Pending fees from the students and to conduct readmissions to II and III year Students
- 8. It was decided that if the admissions take place and if the fees are well collected then the proportionate salary would be paid to the staff from August.
- 9. The Bishop appreciated the effort of the college and suggested the members to plan for Infrastructural development of the College.
