- 8. You will be entitled to 12 days of casual leave in a year, which may be sanctioned by the Principal from time to time, and 10 days of Earned leave per year, which is to be sanctioned by the Correspondent at his discretion. However, it cannot be claimed as a matter of right.
- 9. In case of absence for a consecutive period of 7(seven) days, without any reasonable cause or without taking prior permission, the management will be entitled to draw the presumption of abandonment of service and terminate/discharge you from service. Sick leave shall be availed by presenting the fitness certificate from the assigned medical practitioner. Notice tendered at the address given by you shall be treated as due notice.
